- (2) Faculty personnel are compensated under the provisions of Procedure 8-2-102.1 Compensation Plan for Unclassified Faculty Personnel.
- (3) Unclassified Non-Teaching Personnel are compensated under the provisions of Procedure 8-2-102.2, Compensation Plan for Unclassified Non-Teaching Personnel (UNTP).
- (4) Temporary Grant Personnel are compensated under the provisions of Procedure 8-2-108.1 Temporary Grant Positions/Employment.
- (5) Employees in Federal and other restricted programs are compensated under (1),
  (2), or (3), or under the specific provisions of the restricted program, all subject to the approval of the State Board for Technical and Comprehensive Education.
- (6) Unclassified Vice Presidents are compensated under the provisions of Procedure 8-2-102.3, Compensation Plan for Unclassified Senior Vice Presidents, Vice Presidents, Associate Vice Presidents, and Assistant Vice Presidents.
- Unclassified Presidents are compensated under the provisions of Policy 8-2-111, Employment/Compensation Plan for Technical College Presidents.
- (8) System Office executive level unclassified positions, as determined by the Budget and Control Board's Office of Human Resources, are compensated under the provisions of the Executive Compensation System as outlined in Section 19-706.04 B. of the State Human Resources Regulations.
- (9) The Executive Director of the State Board for Technical and Comprehensive Education is compensated in accordance with Section 19-706.04 A. of the State Human Resources Regulations subject to the provisions of the Agency Head Salary Commission and the Budget and Control Board.
